72-13 Apologies for Absence

Apologies for absence were submitted on behalf of a Police representative and Cornwall Councillor G Trubody.

74-13 Police Report

The January police report stated nil incidents for Antony and Wilcove.

75-13 Minutes of the previous meeting

The minutes of the previous meeting held on 8th January 2014 were taken as read, confirmed and signed by the Chairman.

76-13 Matters arising from the minutes

a) Signs at Tregantle Corner:- pursuant to minute 66-13(a) – A letter has been received from ‘The Adventure Bay Surf School’ requesting permission to re-instate signage at Tregantle Corner. The Clerk will reply stating that the Parish Council will not give permission for any signs to be replaced at the junction as numerous complaints were received from Sheviock and Crafhole Parish Council about the number of signs distracting motorists. However, it was suggested that Mr Kinsman write to Cornwall Council and obtain planning permission to have a professionally made directional sign installed.

The Clerk will contact Mr R Constance of Cornwall Council Highways and discuss the possibility of placing a ‘No Advertising’ sign at Tregantle Corner ‘by order of Antony Parish Council’.

b) Proposed Jetty Extension:- pursuant to minute 66-13(b) – A letter has been received from Torpoint Town Council confirming their support for a meeting to be held in Wilcove with the developers of the Jetty once the Planning Application has been submitted. The Clerk will contact Mr T Watson to ascertain the expected date for submission of the plans.

c) Solar Farm:- pursuant to minute 66-13(e) – Councillor Lady D Coward informed members that she had met with St John Parish Council and they too had no objection to the proposed solar farm planning application.

d) Play Area:- pursuant to minute 66-13(f) – Mr G Shepherd reported that the play equipment will be installed on the 26th February 2014. Councillor W A Lobb and Mr J Vigus will assist with

the maintenance of the play area. The opening ceremony of the play area will take place on Sunday 9th March 2014.
