14.17 Minutes of the previous Meeting.

15.17 a 4.17b 105.16 c 90.16 c 76.16 f 61.16 l 44.16 n 36.16 d **Wilcove / Antony Playpark** fencing post needs repairing and play equipment treating.

Repairs are in progress

Action : Work is still in progress.

An area in the closed churchyard has been identified as needing remedial action to be taken, as many parents and children use this access path the school on a daily basis. It is often muddy and slippery.

The footpath is both slippery and overgrown and dangerous for pedestrians to use.

Cllr Richards has not contacted Cllr Pidgen yet. It was felt that the Council were not keen to commit to the necessary levels funding and work involved in planning such a footpath at this time. Given the low numbers of people who would use this route and the potential for maintenance issues.

Sherryl Murray MP has confirmed that an incident did occur on Hms Argyll and a training missile. She is awaiting further details from the Naval base Commander and an assurance that this cannot happen again.

The road sign which has been vandalised has not been replaced yet. Parking issues have resulted in the verges being destroyed as they are used by cars. Cornwall Housing are investigating parking issues.
