It is important that the Parishioners of Antony Parish look at the boundary commission review and comment accordingly.

Simon Ryan of the Peninsula trust talked about a new project he is pursuing, which will help to resolve the lack of affordable good quality rental properties on the Peninsula. The hope is for Cornwall Council to allow this Community Housing Trust to purchase or lease various properties – usually empty Council houses, renovate or convert them and rent them out to local residents. The Trust is also looking for brownfield sites / derelict buildings etc to develop as local rental housing. The Ship pub site in Cawsand is a project they are currently working on.
