Peninsula trust intends to ask Cornwall Council to devolve them responsibility for the Tregantle Car Park. The car park would be free and measures would be taken to stop on and off road parking along Military Rd and develop the land featuring visitor destination boardings and centre.

The Council agreed unanimously to support this project and write a letter to this effect.
