Minutes of meeting of the Antony Parish Council will be held on Tuesday 10th Sept 2019 at Antony Village Hall at 7.30pm.

Cllr Shepherd requested that an amendment be made to item 30.19d in 170719 minutes. It was duly noted - Cllr Shepherd raised objections to an email sent out from the clerk to Mrs Caley and Mrs Butcher stating that the Parish Council were happy that a new Community Wilcove group could start raising funds and look into the purchase of additional play equipment in the Playground area.

The minutes were reviewed and approved by the full Council.

Mrs Butcher kindly gave a well researched report on potential funding opportunities and play equipment that had been installed in local play areas.

As a result of The Community Open meeting held in July , it was felt that the Play area could only accommodate one additional piece of equipment and that the rest of the area should be made available for general ball use. No fund raising has been undertaken to date.
