ANTONY PARISH COUNCIL

Minutes of meeting of the Antony Parish Council Tuesday 7th Sept 2021 held at Wilcove Community Hall at 7.30pm.

43.21 Those present : Cllr Coward, Cllr Shepherd , Cllr Bulmer, Cllr Lobb , Cllr Murray , County Cllr Ewert , and the Clerk for Antony Parish Council.

45.21 County Cllr Ewert Report was received.

Cllr Ewert informed the Council of the 20 is plenty scheme, there would be a current cost of £5,500 - £6,000 if the PC wanted to pursue it. It was agreed to wait until CC issue more information about the scheme.

Cllr Ewert had liaised with Cornwall highways regarding the scheme the Pengelly Hill safe pedestrian access project. Cornwall currently have no plans to pursue this.

Cllr Ewert had contacted Cornwall housing regarding the tenants of 1 Pengelly Close, however, the issue is still ongoing.

Cllr Ewert met with Antony Estates and they suggested organising a Councillors day (possibly in the spring of 2022). The Councillors were keen to attend.

Cllr Ewert informed the Pc of the no chemical hot foam treatment that Millbrook PC are trialling. It costs £500 per day. A possible suggestion is that the cluster parishes purchase one machine between them (£20,000).

Members of the PC raised the question of various highways issues in the Parish. **Action:** Cllr Ewert to organise a walk through the parish with members of the Pc and Mr Glassup.

- **53.21 Policies** for review. None.
- **54.21 Playpark equipment installation.** Cllr Bulmer(Antony) and Murray(Wilcove) have agreed to be the contact points for both playpark installations
- **55.21 Wacker quay.** It appears that the picnic area maybe subject to a rewilding policy by the Tamar Trust. Given the prevalence of deer and their propensity to carry ticks, the members raised health and safety concerns for families using this area. The safety rail needs replacing and one of the seats is missing. **Action:** Clerk to write to the Trust and raise these concerns.
- **56.21 Ivy / Elm Cottage hedges. Action:** Clerk to contact Mr Trinnick to request the hedges been cut back to the wall.
- **57.21 Wilcove moorings.** The members of the PC are concerned that the Wilcove foreshore and lake are not being managed properly by the Wilcove moorings association. **Action:** Clerk to invite Mr Knott and members of the Mooring committee to the next PC meeting to discuss their concerns.
- **58.21 Floral Boats in Wilcove**. Cllrs Shepherd and Murray have refurbished 2 dinghies and intend to site them in the village. It was agreed to approach the Wilcove gardening club to ak if they would be happy to plant them up. No budget was allocated for this activity.

Cllr Ewert commended the Pc on the Antony playpark and commented on how family friendly it is.
